## **Domestic Cots Certified to Australian/New Zealand Standard 2172 or Consumer Protection Notice Number 6 of 2005**

The following cots have been tested and found to comply with Australian/New Zealand Standard 2172:2003 (or 2010) *Cots for household use - Safety requirements* or the Australian mandatory standard for domestic cots as defined under Consumer Protection Notice Number 6 of 2005.

Those cots that comply with all of the requirements of the Australian/New Zealand Standard for Domestic Cots (AS/NZS 2172) – not just the mandatory parts – are marked in red. These products have been subjected to additional requirements including toxicity tests.

This list **does not cover folding cots** – a different standard and Consumer Protection Notice applies to folding cots. The Consumer Protection Notice **is mandatory**.

**Blue Tick Certification** requires that suppliers sign a certification agreement undertaking to maintain consistent quality of their products, to maintain a register of complaints, to notify the Institute of product changes, to have the products retested every three years and when standards change, and to submit to spot audits of product quality.

Blue Tick Certification is open to all suppliers whose products meet the required standard and involves an annual licence fee to cover the cost of monitoring quality.
